Call for Papers: “Conflict, Migration, and Displacement”

17th Annual Workshop of the Households in Conflict Network

Online event hosted by the University of Göttingen (potentially hybrid if the situation allows it)

Dates: 11-12 October 2021

Considering that one percent of the world population is displaced and ten percent of the world population lives under conflict, the complex nexus of forced migration, development, and security is central to the analysis of household welfare. When accounting for the consequences of the current pandemic, both numbers are likely to continue their rising trends. Any empirical analysis of the link between conflict and forced migration faces issues due to endogeneity, generalizability, or data quality. The workshop thus aims at discussing creative and innovative approaches that allow dealing with the above issues to provide evidence, which can be used to benefit a non-negligible share of the world population.

The keynote speaker is [Mathias Thoenig](#), Professor of Economics at the School of Business and Economics at the University of Lausanne. In an **open plenary session**, which is jointly organized by the [Centre for Global Migration Studies \(CeMig\)](#) and the [German Development Institute/Deutsches Institut für Entwicklungspolitik \(DIE\)](#), we discuss “**Migration and Security Policy**” with [Ruben Andersson](#) (Oxford University), [Camille le Coz](#) (Migration Policy Institute), [Mercy Fekadu](#) (Institute for Peace and Security Studies), [Michael Owiso](#) (Maseno University), and [Mathijs le Rutte](#) (UNHCR), followed by moderated discussions in smaller groups.

We are inviting submissions of (preferably) full papers or extended abstracts by **May 31, 2021 (23:59 CET)** to hicn2021@uni-goettingen.de. Authors will be informed about the final paper selection by June 30, 2021. Authors submitting extended abstracts will need to submit full papers by September 15, 2021. As in previous years, we also welcome creative and innovative papers analyzing violent conflict that do not directly address the annual theme. We are thus inviting papers on any topic within the empirical, micro-level analysis of the intersection of violent conflict and socio-economic development.
